The City Planning and Zoning commission presented the post factum rezoning of Delzer's Outlot B into three (3) plats, designated, west to east, as Plat 1, Plat 2, and Plat 3. The recommendation is being made at this time because when the original applications for the building permits were submitted for approval in both 2020 and 2021, the rezoning was not addressed. N. Kathy Huettle discussed possible names to suggest for one open position on the Planning and Zoning board and will present them at the next meeting. Also, the Planning and Zoning Commission plans to address Dangerous and Abandoned Buildings in their future meetings.

Julie Hein from North Dakota Rural Water Association presented to council the new state guidelines requiring backflow prevention to keep contaminants from flowing into drinking water. N. Schneider moves to approve the containment program. S. Adams seconds. Vote all yea. m/c/a

Estvold-Ackerman: Nathan Amack updated the city that Jetting and Televising plans/specifications have been submitted to contractors, included a checklist for the ARPA finds, and confirmed NDDEQ guidelines for the Back Flow prevention program.

N. Schneider motions to sign a service agreement with ND Sewage Pump & Lift Service Co, Inc. R. Westman seconds the motion. Vote all yea. m/c/a

Don Krebsbach informed the city that there is a contract with Aramark, and that we cannot cancel with them at this time. However, the city can restructure and eliminate items to save money in a new contract. An inventory will be done, and a list of items will be brought to vote next council meeting. A street light is out, and Don will call and get someone to fix it. Also, Don let the council know that February was a low month for citations due to the County contact person being out of the office, but it is expected to pick up in March.
